RETURNED SOLDIERS' INSURANCE

ANY PERSON WHO SERVED WITH THE CANADIAN FORCES IS ENTITLED TO PARTICIPATE IN THE INSURANCE MADE AVAILABLE UNDER THE RETURNED SOLDIERS' INSURANCE ACT. IT IS UNNECESSARY THAT THE APPLICANT BE LIVING IN CANADA.

"LIFE" POLICIES ARE ISSUED AT VERY LOW RATES AND THE PREMIUMS CAN BE PAID MONTHLY, WITHOUT EXTRA CHARGE, IF THAT METHOD IS MORE SUITABLE TO THE INSURED. THERE ARE NO RESTRICTIONS IN THE POLICY WITH REGARD TO RESIDENCE, TRAVEL OR OCCUPATION AND THERE ARE FEATURES WHICH ALLOW IT TO BE COMPARED FAVOURABLY WITH ENDOWMENT INSURANCE. AFTER THE POLICY IS IN FORCE FOR TWO YEARS, IT CANNOT LAPSE UPON THE NON-PAYMENT OF ANY PREMIUM.

APPLICATIONS WILL BE ACCEPTED UNTIL SEPT. 1, 1923, ONLY. INFORMATION MAY BE OBTAINED FROM ANY OFFICE OF THE DEPT. OF SOLDIERS' CIVIL RE-ESTABLISHMENT OR BY FILLING IN THE PARTICULARS ON THE BACK OF THIS FORM AND MAILING IT TO THE COMMISSIONERS, RETURNED SOLDIERS' INSURANCE, OTTAWA; POSTAGE FREE, WHEN MAILED FROM ANY POINT IN CANADA.
