At the conclusion of the Victory Loan Campaign in 1919 the committee in charge of district No. 7 had a fund in hand from commissions on the sale of Bonds amounting to \$588.00. This amount the committee decided to use as a nucleus of a Fund for the erection of a suitable memorial to the brave boys from district No. 7 who had given their lives in the "Great War".

Accordingly in June 1919, a public meeting of the inhabitants of the district was convened in the Presbyterian Church in Pugwash. This meeting was largely attended and was addressed by Col. C. E. Bent and Col. J. L. Ralston.

After hearing the views of those present, it was finally and unanimously decided that the suggestion of the Victory Loan Committee be adopted and commended.

It was then decided by resolution that the same committee be re-appointed to carry out the erection of a suitable monument of a granite base with a bronze figure.

The following committee was then appointed :—
D. Mackintosh, M.D., R. L. McDonald, H. F. Elliott, J. L. McDonald, G. N. Allan, S. P. Borden, F. R. Dakin, Rev. Mr. Millar, Rev. Mr. Whitman and Rev. Mr. Lund.

It was further resolved that full power be granted this committee to decide upon a design for the monument to select a site for same and to collect subscriptions for the fund.

This committee subsequently met and appointed D. Mackintosh, M.D. chairman and H. F. Elliott, Secretary of the committee.

They also appointed Col. C. E. Bent, J. L. McDonald and F. R. Dakin a committee to look over and report on different sites for the monument. Dr. Mackintosh was appointed to solicit subscriptions.

The committee on sites, later reported verbally, in favor of a site on the James Black lot, now in possession of the Dominion Coal Co., one in the Cemetery, or one on the school house grounds. The last two sites were not considered by the main committee. The following committee was appointed to interview Mr Stewart of the Dominion Coal Co. at Springhill to ascertain if the Black lot was obtainable,—R. L. McDonald, Dr.

Mackintosh, C. E. Bent and G. N. Allan. (F. R. Dakin acted for C. E. Bent on this committee).

After visiting Springhill the committee found that said site was not available. Later the main committee selected and eventually bought, at a price of eight hundred dollars, the old W. H. Brown Corner lot, where the monument now stands.

At the time of starting the subscription book on its rounds, it was felt by some members of the committee that unless the committee itself, and the village subscribed generously, (to an extent of at least fifteen hundred dollars) it would be useless to go further, if the idea of the erection of a suitable and creditable memorial was to be accomplished.

Consequently an effective effort was made at that time to make the subscriptions in the village, as large as possible, with the gratifying result shown by the list.

Dr. Mackintosh having reported encouraging response to subscriptions it was decided to go on with the monument.

At this meeting the Chairman and Secretary were instructed to correspond with different firms, asking for designs and tenders.

This was done, and finally contracts were awarded to David Sharp of the Colonial Granite Works at New Glasgow for the pedestal and to The S. F. McCann & Sons Co. of Boston for the Bronze Statue.

The committee then went on with the purchase and grading of the lot and the completion of the monument.

Subsequently the committee decided to have a fence built around the lot and on the suggestion of the chairman (Dr. Mackintosh) with the approval of the Secretary (H. F. Elliott) R. L. McDonald was requested to over-see the erection of a suitable fence. The present fence was then erected at the smallest cost possible to the committee. Mr McDonald furnishing the stones, for the pipe posts free of charge to the committee.

After the erection of the monument the unveiling took place on July 1st., 1922.

The following program was carried out in the

presence of a vast concourse of people from all parts of the County.

Program

1. Procession of veterans of the "Great War" and school children bearing bouquets of flowers, was lead by Col. C. E. Bent mounted on his Russian charger and by the Pugwash Band.
2. Remarks by Chairman.

At the close up meeting of the Victory Loan campaign in 1919 the committee in charge had on hand for commissions the sum of \$588.00.

They agreed to make this sum the nucleus of a fund for erecting a suitable monument to the brave boys who fell in the late war.

This amount was subsequently added to by the sum of \$100.00 contributed by the ladies of the Patriotic League.

To carry this scheme into effect a public meeting was called. Col. Bent and Col. Ralston were present at this meeting and gave stirring addresses in sympathy with the object of the meeting.

After a liberal discussion the meeting unanimously endorsed the Victory Loan Committee and reappointed them as a Soldiers Memorial Committee, with full power to select a design, secure a site, receive subscriptions and carry out the details of the work. This they have endeavored to do to the best of their judgment and ability with the result that we have here before us a Memorial costing with site and equipment in the vicinity of \$5,000.00.

Let us say that our appeal to the citizens of Pugwash and surrounding district and also to former residents now living abroad, was met with a splendid response, and I want to take this opportunity of thanking those subscribers for their spontaneous assistance and generous sympathy.

It is our intention according as funds are available, to convert this plot into a "Memorial Park", which at the time we took it over, was a howling wilderness and a veritable eyesore. The park will be laid out with walks and seats in harmony with the

objects of the Memorial, limited only by the amount of funds at our disposal.

15. God Save the King.

At the conclusion of the ceremony, a Tea-meeting for the supplementing of funds was held in the Masons Hall.

Minutes of Meetings December 1922.

After due notice a public meeting was held in the Masons Hall, when the Memorial Committee submitted a report of their work and were discharged.

At this meeting it was decided that Polling district No. 7, to which the monument belongs, be incorporated by act of the Local Legislature under the name of The Pugwash Soldiers Memorial.

The following provisional Trustees were appointed,—D. Mackintosh, M.D., H. F. Elliott and F. R. Dakin.

H. F. Elliott and F. R. Dakin were instructed to see that the Act of Incorporation be put through.

It was also decided that the first annual meeting be held on the 1st. of July 1923.

July 1st, 1923.

The first annual meeting was held in Mason Hall. The provisional Trustees reported and submitted the

Act of Incorporation, which had been passed at the last session of the local Legislature and this approved. In terms of said Act the following were appointed for the ensuing year.

Trustees—Dr. Mackintosh, G. N. Allan, M.P.P. and J. V. Clarke.

Auditors—F. R. Dakin, H. F. Elliott and Dr. W. V. Goodwin.

BILL NO. 117

An Act to incorporate the Inhabitants of polling District No. Seven of the County of Cumberland.

Whereas after the conclusion of the Great War a committee of the citizens of the village of Pugwash in polling district No. seven in the County of Cumberland, appealed to the inhabitants of the said polling district for contributions to a fund to be applied towards the erection and maintenance of a suitable monument to be erected at Pugwash aforesaid to the memory of the men from the said polling district who gave their lives for their country in the Great War.

And whereas in response to such appeal contributions amounting to several thousand dollars were received.

And whereas lands have been required and a suitable monument has been erected thereon at Pugwash aforesaid for the purpose aforesaid,

And whereas the said lands are comprised in a conveyance dated the 25th day of November 1919, and registered in the Registry of Deeds at Amherst in book 139 at page 374 and made between Hubert G. Brown of the one part and D. Mackintosh and H. F. Elliot trustees, of the other part.

And whereas the inhabitants of the said polling district are desirous of becoming incorporated for the purpose of holding the said monument and the land upon which the same was erected and for the further purpose of making provisions by by-laws for the care of the said lands and of the said monument,

Be it therefore enacted by the Governor, Council and Assembly as follows:—

1 The inhabitants of the said polling district are hereby created a body corporate by the name of "Pugwash Soldiers' Memorial, Cumberland County, Nova Scotia," and such body corporate by the name of perpetual succession and a seal.

2 D. Mackintosh, M. D., Herbert F. Elliot and Fred R. Dakin, merchants all of Pugwash aforesaid, are here by appointed trustees of the said corporation and they shall be entitled to hold such office until their successors are elected.

3 The said land, and the said monument are hereby vested in the said corporation.

4 The said trustees may make by-laws for the following purposes:

- (a) Fixing the time and place for an annual meeting of the inhabitants of the said polling districts,
- (b) The investments of money belonging to the said corporation,
- (c) The employment of workmen to keep the said lands and the said monument in suitable condition,
- (d) Generally for any purpose in connection with the foregoing,

and such by-laws when approved by the Lieutenant-Governor in Council shall be valid and binding.

5 An annual meeting of the inhabitants of the said polling district shall be held at such time and place as the Trustees may by by-law determine. The first annual meeting shall be held on the First day of July 1923, and if no other time is perscribed the annual meeting shall be held on the First day of July in every year.

6 Ten days notice at the least specifying the place, the day and the hour of meeting shall be given by the Trustees to the inhabitants of the said polling division by posting at least three notices thereof in the said polling division.

7 All inhabitants of the said polling district whose names are registered on the list of voters of the said polling division entitled to vote at an election of a member to represent the said County of Cumberland in the House of Assembly of the Province of Nova Scotia shall be entitled to vote at such meetings. Votes must be given personally and not by proxy.

8 The trustees shall cause true accounts to be kept of the sums of money received and expended by them; and the matter in respect of which such receipt and expenditure takes place and the credits and liabilities of the corporation. Three auditors shall be appointed at each annual meeting, and the books of account shall be open to the inspection of such auditors during business hours five days before the annual meeting.

9 Three trustees shall be elected at the annual meeting. The retiring trustees shall in each case be eligible for re-election.

By-Laws of "Pugwash Memorial, Cumberland County, Nova Scotia", as Provided and Incorporated by Act, No. 138 of the Legislature of Nova Scotia, Passed in the year A. D. 1923.

—PREAMBLE—

Whenever the word "Memorial" is used in the following By-Laws it shall mean, the Pugwash Memorial as above mentioned, and as set uot in said Act.

And wherever the word "Inhabitants" is used in the said following By-Laws, it shall mean the inhabitants of Polling District No. 7 in said County of Cumberland and Province of Nova Scotia.

—BY-LAWS—

1. The regular annual meeting of said Inhabitants and other persons entitled to attend and vote shall be held on the first Tuesday of the month of September in each year hereafter, commencing in the year 1924 at the hour of 2.30 o'clock in the afternoon in the village of Pugwash in said County of Cumberland, and at such hall or place in said Pugwash as the Trustees may decide, which shall be stated in the notice of the meetings.

2. At least ten days previous notice shall be given of the holding of such meetings by posting, at least, three notices in some public places in said Polling District No. 7.

3. Special meetings of said Memorial may be called at any time by a majority of the Trustees, and shall be called by said Trustees whenever a majority in number of the persons entitled to vote in writing request such Special Meeting, notice of the holding of which shall be as No. 2 hereof mentioned.

4. Each person present at any of said meetings and who is entitled to vote shall have one vote, but there shall be no voting by proxy.

5. At the said Regular Annual Meeting, or at any Special Meeting, at least five of the inhabitanst or persons entitled to vote shall constitute a quorum for the despatch of business. In case of there not being a quorum present the meeting shall stand adjourned *sine die* or to some other date as the Trustees, or a majority of them present at such meeting, shall decide, but if adjourned no notice, other than what is given at the meeting, will be necessary.

6. As provided by said Act of Incorporation there shall be three trustees, those already appointed holding office until the next Regular Annual Meeting in 1924 when they shall all retire from office, and then one Trustee shall be elected for three years, another for two years and a third for ~~one~~ year all by a majority vote of those present and entitled to vote, and the same course shall be adopted at every subsequent Regular Annual Meeting or adjournment thereof as above provided for, but said trustees in any case shall be eligible for re-election.

7. In case of the death, removal from the District or inability of any Trustee to act after being elected, the

remaining Trustees shall fill the vacancy until the next Regular Annual Meeting, or until another Trustee, or other Trustees are elected, but subject to the above the Trustees so elected shall hold office until their successors are duly elected as hereinbefore mentioned.

8. As soon as convenient after their election the said Trustees shall appoint one of their number Chairman whose duty it shall be to preside at all Regular and Special meetings of the "Memorial" as well as at all meetings of the Trustees, and direct the business thereat and thereof. The Trustees shall also appoint one of their number or some other suitable person Secretary-Treasurer who shall receive all monies and keep a true and correct account of the same, as also keep minutes of all the meetings, Regular and Special, as also of the Trustees, and all of which minutes shall be signed by the Chairman and Secretary-Treasurer.

9. In the name and to the credit of "Pugwash Memorial, Cumberland County, Nova Scotia," all funds of the "Memorial" shall be deposited in the Savings Department of the Bank of Nova Scotia (Pugwash Branch) and shall only be withdrawn by cheque signed by the Secretary-Treasurer, counter signed by the Chairman of the Trustees.

10. The Trustees are empowered to use all or any part of the funds of said Memorial for the up-keep of the Monument erected and the grounds connected therewith or on which the same stands, and for such other purposes in connection with said Memorial as they may consider wise, necessary and advisable.

11. In accordance with the Act of Incorporation three Auditors shall be appointed at each Regular Annual Meeting, whose duty it will be to go over the accounts, and make a report at each Regular Annual Meeting, and to assist them in so doing the books and papers of the Secretary-Treasurer shall be open to the inspection of the Auditors at any time during business hours for, at least, five days previous to the holding of the Annual Meeting.

12. The Trustees are hereby authorized, either by soliciting subscriptions, or other legal means, to raise sufficient funds for the purpose of keeping the lot of land and monument referred to in said Act of Incorporation in proper condition and repair.

13. The Trustees are hereby authorized to purchase necessary material and employ workmen to keep said lot and monument in proper condition, and use the funds of said "Memorial" to pay therefor.

14. In addition to said "Inhabitants", all present or future contributors to said "Memorial," or the funds connected therewith, shall have the right to attend and vote at all of said meetings, regular and special.

15. No change or alteration in, or addition to these By-laws shall be considered unless at least thirty days notice previous to the holding of any Regular Meeting shall be given in writing to the Secretary-Treasurer specifying the change, alteration or addition proposed when the same shall be subject to the approval of the Trustees or a majority of them before becoming effective.
