## The Active Service Voters Act, 1945 Chapter 14, Acts of 1945.

# REGULATIONS

#### (Made and approved, September 6th, 1945 as amended October 2, 1945)

1. In these Regulations unless the context otherwise requires:

(a) "Active Service Voter" means every person, male or female, irrespective of age, who is a British subject and a member of the naval, military or air forces of His Majesty including any person in training under The National Resources Mobilization Act, 1940 (Dominion) or a nurse or a nursing sister or any person in any other capacity with these forces who was ordinarily resident in Nova Scotia at the time of enrolment for active service as dfined by the provisions of The Provincial Electoral Franchise Act, 1945.

(b) "Special Returning Officr" means a person to whom a special writ of election is addressed under the provisions of The Active Service Voters Act, 1945 and these Regulations.

(c) "Special Writ of Election" means the writ of election addressed to the special returning officer for the purpose of taking the vote of the active service voters who are entitled to vote at an election for a member or members of the House of Assembly.

(d) "Extra-Provincial Active Service Voter" means an active service voter who at the date of a writ for any election is serving outside of Nova Scotia.

2. Subject to the provisions of Chapter 14 of the Acts of 1945, The Nova Scotia Elections Act, and The Provincial Electoral Franchise Act, 1945, every active service voter as defined by these Regulations shall be entitled to vote at an election for a member or members of the House of Assembly of the Province and be entered on the list of voters and to cast his vote for a candidate or candidates in the polling district in which he is under the provisions of The Provincial Electoral Franchise Act, 1945, entitled to vote.

## PART I

## Active Service Voting in the Province

3. Whenever it is necessary for the purpose of carrying out the provisions of the Active Service Voters Act, 1945, to appoint a person to be Special Returning Officer for the purpose of taking the votes of active service voters serving in Nova Scotia such appointment shall be made in the same manner as in the case of the appointment of a Returning Officer under the provisions of The Nova Scotia Elections Act.

(2) The special returning officer shall superintend the preparation of the lists of active service voters who are entitled to vote at any election for which writs have been issued and the taking, sorting and counting of the votes cast.

4. Every special writ of election shall bear the same date as the writs issued under the Nova Scotia Elections Act, and shall direct the special returning officer to establish such polls as may be necessary for the purpose of taking the votes of active service voters.

5. The special returning officer shall on receiving the special writ of election forthwith endorse thereon the date on which he received the same, and before taking any further action thereon he shall take the oath of office in the Form B in the first schedule to the Nova Scotia Elections Act.

6. The special returning officer by a commission unde his hand and in Form C in the first schedule to the Nova Scotia Elections Act shall appoint an election clerk and may at any time during the election appoint in the same manner another clerk if the one so appointed resigns, refuses to act, or is unable to perform his duties as such clerk.

7. The election clerk shall assist the special returning officer in the performance of his duties and act in his stead as special returning officer whenever the special returning officer refuses to act, or is disqualified or unable to perform his duties or has not been replaced by another.

8. The election clerk shall before acting as such clerk take the oath of office in Form D in the first schedule to the Nova Scotia Elections Act.

**9.** (1) The special returning officer shall without delay after receiving any special writ of election fix the territorial limits of polling districts in which polls shall be established for the purpose of taking the votes of active service voters as provided in said Chapter 14 and these Regulations and shall appoint under his hand, in Form No. 1 in the schedule hereto, as many persons to be registrars of active service voters in such polling districts where persons are on active service as will insure that there shall be one registrar for not more than six hundred voters and the special returning officer shall assign to each of them such polling district or districts as he may deem necessary for the purpose.

(2) The special returning officer shall keep a record of the names and addresses of the registrars and of the polling districts for which they have been appointed and any candidate or person authorized in writing by a candidate shall be entitled to inspect such record and make extracts therefrom.

(3) Every registrar of active service voters before acting as such shall take before the special returning officer or a Justice of the Peace an oath in Form No. 2 in the schedule hereto.

10, (1) Every Registrar shall immediately after having taken the oath of office post or cause to be posted up in at least two conspicuous places within the polling district or districts for which he has been appointed copies of the poster notice in Form No. 3 in the schedule to this Act, setting forth the date, the place and the hours at which he will hold sittings for four consecutive days to receive applications from active service voters to have their names placed on the list of voters. The first date on which the registrar shall hold sittings shall be on the thirtieth day preceding the day for the holding of the polls except that where the aforesaid thirtieth day preceding the day for holding of the polls is Sunday he shall hold his first sittings on the following day.

(2) The Registrar shall also before nine o'clock of the first day fixed for the registration of active service voters cause at least five copies of such notices to be posted up in different conspicuous places outside of or near to the place where he sits for the registration of active service voters and the said notice shall be kept so posted throughout the whole period of registration, and if such notice is removed or defaced it shall be the duty of the registrar to replace it with a duplicate thereof. 11. Every registrar shall provide within the polling district or districts for which he has been appointed a convenient place properly lighted and heated for the purpose of the registration of active service voters. He shall for such purpose attend and sit thereat for the four consecutive days aforesaid from nine o'clock in the forenoon until nine o'clock in the afternoon with intermissions from one o'clock to two o'clock and from six o'clock to seven o'clock except that where one of the days is a Sunday he shall not attend on that day. One representative of each reconized and opposed political interest shall be permitted to be present in the place of registration but shall not except with the permission of the registrar have any right to take part or intervene in the proceedings.

12. When a person claiming to be entitled to be registered as an active service voter applies for registration the registrar shall proceed as follows:

(a) He shall administer to the applicant orally under oath or solemn affirmation the interrogatories applicable in each cse as contained in Form No. 4 in the schedule hereto;

(b) If it appears to the registrar from the answers given by the applicant to such interrogatories that the apr plicant is entitled to be registered as an active service votd the registrar shall announce that the application is grante, and the name, rank or occupation of the voter, the naval military or airforce unit to which he or she is attached, the residence of such elector at the time of joining the active naval, military or airforce and the name of the polling district in which such voter is entitled to vote shall be registered on the list.

(c) The Registrar shall enter on such list of voters, in addition to the names of those who have appeared before him, the names of all active service voters then stationed in such polling district and entitled to vote but who, at the time of such sittings being absent therefrom on leave as certified by their commanding officer, were unable to appear personally before such Registrar in order to have their names entered on such lists as herein provided.

13. The Registrar shall on or before the third day after the closing of registration:

(a) Prepare a true and complete list certified as such under his hand for the polling district or districts for which he has been appointed and shall certify under his hand at the foot or end of each such list as in Form No. 5 in the schedule hereto, and the registrar shall register on such preliminary list the name of every person whose application for registration as an active service voter has been granted; the names on such lists shall be arranged alphabetically according to the first letter of the surname;

(b) Post a certified copy of such lists in two conspicuous places in the polling district or districts for which he has been appointed.

14. (1) Every registrar shall by previous notice posted for three days give notice as to the days, hours and place within the polling district at which he will sit for the purpose of revising the lists. He shall first sit on the twenty-first day preceding the day for holding of the polls and shall continue his sittings for three consecutive days exclusive of Sunday. One reprelsentative of each recognized and opposed political interest shall be permitted to be present at the revising of the lists and shall not except with the permission of the Registrar have any right to take part or intervene in the proceedings.

(2) Every registrar shall at the time and place appointed attend for the purpose of hearing and disposing of applications for revision of the list prepared for the polling district or districts for which he has been appointed.

15. The Registrar shall as soon as possible after the conclusion of his sittings and not later than the seventeenth day preceding the holding of the polls

(a) Initial all changes or additions made to the lists of active service voters and shall write or sign at the foot or end of such lists the words following.

> Registrar of active service voters at polling district .....;"

(b) Post a certified copy of such final list in two conspicuous places in the polling district for which he has been appointed;

(c) Deliver or mail by registered post to the special returning officer a statement of such changes or additions;

(d) Deliver or mail by registered post to the special returning officer and the Provincial Secretary a certified copy of the list of active service voters which he has prepared under the provisions of said Chapter 14 and these Regulations.

16. On a poll being granted the special returning officer shall:

(a) Appoint by a commission under his hand in Form K in the first schedule to the Nova Scotia Elections Act one presiding officer for each polling district established for the purpose of taking the votes of active service voters who shall before acting as such take the oath of office in Form L in the first schedule to the Nova Scotia Elections Act;

(b) Appoint by a commission under his hand in Form M in the first schedule to the Nova Scotia Elections Act one poll clerk for each polling district established for the purpose of taking the votes of active service voters who shall before acting as such take the oath of office in Form N in the first schedule to the Nova Scotia Elections Act;

(c) Furnish each presiding officer with a copy of the lists of active service voters for the polling district for which he has been appointed the same to be a copy certified by the registrar;

(d) Deliver or cause to be delivered by registered mail or otherwise to each presiding officer at least twenty-four hours before the hour appointed by law for opening the poll a ballot box to receive the ballot papers of the active service voters;

(e) Furnish each presiding officer with a sufficient supply of ballot papers to supply the number of active service voters on the list of such polling district and with the necessary materials for voters to vote and with a poll book and at least one copy of said Chapter 14 and these Regulations and the Nova Scotia Elections Act, and with a sufficient number of copies of a printed list of the names and the surnames of candidates officially nominated in each electoral district to be posted and available wherever a poll is established. Upon such list shall be inserted after the names and surname of each candidate the designating words or letters currently used to indicate his political affiliation. The special returning officer shall keep an exact record of the number of ballot papers furnished to each presiding officer; and he shall at the time he furnishes such ballot papers also deliver to each presiding officer a certificate signed by him of the number of ballot papers so furnished.

17. (1) The ballot papers for taking the vote of active service voters shall be in Form No. 7 in the schedule hereto; and shall have only one space in which an appropriate place is provided for the active service voter to write the name of the candidate or candidates for whom he wishes to vote.

(2) Every person who is entitled to vote shall receive from the presiding officer a ballot paper on the back of which the presiding officer has entered in the space provided therefor the name of the electoral district opposite the name on the polling list of the person tendering his vote.

(3) The presiding officer shall also, previous to handing the ballot to the voter, place his initials where indicated on the prescribed form so that when the ballot is folded his initials can be seen without opening it and place on the back of the counterfoil a number corresponding to that placed opposite the voter's name in the poll book.

(4) The presiding officer shall, when handing a ballot paper to the voter, inform him of the names of candidates in the electoral district in which such voter is entitled to cast his ballot.

18. The ballot box shall be made of some durable material with one lock and key and a slit or a narrow opening on the top and so constructed that the ballot papers may be introduced therein but cannot be withdrawn therefrom unless the box unlocked.

19. Every presiding officer shall on election day open the poll assigned to him at the hour of eight o'clock in the forenoon and keep the same open until six o'clock in the afternoon and shall during that time receive the votes of the active service voters duly qualified to vote at such poll in the manner prescribed in the Nova Scotia Elections Act. One representative of each recognized and opposed political interest shall be permitted to be present in the room where the votes are being taken during the whole time the poll remains open. He shall comply with all the provisions of The Nova Scotia Elections Act with respect to persons present at polls as agents for a candidate.

20. (1) Immediately after the close of the polls the presiding officer with the assistance of the poll clerk and in the presence of one representative of each recognized and opposed political interest or such of them as are then present, or if no such representatives are present, then in the presence of two or more voters invited to be present by the presiding officer, shall open the ballot box and proceed to count the votes cast for each candidate, and when the counting of the ballots has been completed he shall make a statement as required by Section 65 (1) of the Nova Scotia Elections Act. One copy of such statement shall be returned to the ballot box along with the ballot papers, one copy shall be forthwith delivered to the special returning officer and one copy each shall be retained by the representatives of each recognized and opposed political interest. No ballot paper shall be rejected for uncertainty as to the candidate intended to be voted for if it is possible to ascertain by mere examination of such ballot paper for whom the active service voter intended to vote; nor shall any ballot be rejected as containing a possible identifying mark unless such mark is obviously intended as such.

(2) Immediately after the counting of the votes has been completed the presiding officer in the presence of the poll clerk and the representatives of the opposed political interests shall enclose in the ballot box the poll book with the statement required to be completed by subsection (1) hereof, together with the list of voters used by him and in a separate envelope or parcel the ballot papers used and also in a separate envelope or parcel the unused ballot papers and he shall endorse each envelope or parcel so as to indicate its contents.

(3) The ballot box shall then be locked and sealed and shall be delivered by registered mail or otherwise to the special reurning officer or his election clerk. (4) The presiding officer and the poll clerk shall respectively take the oath in the Forms W and X in the first schedue to the Nova Scotia Elections Act which shall be annexed to the state ment referred to in subsection (1) hereof and the poll clerk shall have power to administer such oath to the presiding officer.

21. As soon as the presiding officer has completed the statement as required by subsection (1) of Section 21 hereof he shall forthwith report by telegram to the special returning officer the number of votes received by each candidate.

22. (1) The special returning officer shall immediately on receipt of the statement by the presiding officer of the number of votes cast for each candidate communicate the same by telegram to the returning officer for the district in which such candidate has been nominated and the returning officer shall proceed to count the votes cast for such candidate in the usual manner under the Nova Scotia Elections Act.

(2) The special returning officer shall immediately on receipt of the ballot box separate the ballot papers cast for each candidate and forward the same to the returning officer for the district in which such candidate has been nominated.

## PART II

## **Extra-Provincial Active Service Voting**

23. Every extra-provincial active service voter may vote by proxy as hereinafter provided.

24. (1) Every extra-provincial active service voter may appoint in writing in the prescribed form a proxy of the full age of twenty-one years and entitled to vote in the electoral district in which the extra-provincial active service voter is entitled to vote.

(2) Any person may hold any number of appointments for extra-provincial active service voters who are within the degre of relationship to him of wife, husband, sister, brother, parent or child but no person shall hold an appointment for more than one extra-provincial active service voter who is not within such degree of relationship. 25. The Provincial Secretary shall as soon as may be after the issue of a writ for any election request the appropriate naval, military or airforce officers to provide him with a list of all persons, ordinarily resident in Nova Scotia and entitled to vote at an election as provided by these Regulations, with their addresses and the name of their immediate commanding officer. Upon receipt of such list the Provincial Secretary shall thereupon forward to such person a form of proxy, as prescribed in Form No.8, with instructions as to its use and the proper manner of execution.

26. Any extra-provincial active service voter may obtain from the Provincial Secretary an appointment form as prescribed and, subject to the provisions of this Part, shall forward the completed form to the person appointed to act as his proxy.

27. (1) A person who has been appointed a proxy may apply to the Revising Officer at the sittings held for the revision of the lists in accordance with the provisions of The Provincial Electoral Franchise Act, 1945 in the electoral district in which the extra-provincial active service voter is entitled to vote, to be entered upon such list.

(2) Where a person appointed a proxy by an extraprovincial active service voter has received the proxy form subsequent to the sittings, the Revising Officer shall, upon being satisfied as to the date of the receipt of the proxy and the right of the person so appointed a proxy to vote, enter his name upon the list for the appropriate polling district; and, if the lists have been printed and certified to by him, hesh all certify the form of proxy entitling him to vote as such proxy and the official list of voters, shall for all purposes be taken to have been amended in accordance with such certificate. The Revising Officer shall, at the same time, send a certificate to the Presiding Officer concerned that he has entered the name of the proxy on the list of voters and a like certificate to each of the candidates officially nominated, or their representatives at the polling station at which such extra-provincial active service voter is entitled to vote.

28. The Revising Officer shall take evidence on oath as to the right of the extra-provincial active service voter to vote in the electoral district upon the list of which his name is entered and as to the qualifications of the proxy, and if he finds that the extra-provincial active service voter is duly qualified and that the proxy is qualified to act for him, he shall endorse a certificate across the face of the appointment to that effect in the prescribed form, and shall cause the name of the proxy to be entered on the voter's list after the name of the extra-provincial active service voter.

29. A ballot paper shall not be delivered to a person who claims to vote as proxy unless he produces his appointment as a proxy to the presiding officer with the certificate of the revising officer thereon, as provided in section 28, and, if required, takes the oath in the prescribed form—No. 9.

**30.** The presiding officer shall record in the poll book provided for that purpose in the form set forth therein, the fact that the extra-provincial active service voter voted by proxy, showing the name of the proxy, and shall file the appointment and certificate with the election papers and return them to the returning officer in the envelope provided for that purpose.

**31.** A person who has been appointed as a proxy shall be entitled to vote in his own right in the electoral district not-withstanding that he has voted as a proxy for an extra-provincial active service voter.

32. (1) Every person who,—

(a) having appointed any person to act as his proxy, attempts to vote at an election otherwise than by means of such proxy while the appointment of such proxy is in force; or

(b) votes or attempts to vote at any election under the authority of an appointment as a proxy when he knows or has reasonable grounds for supposing that such appointment has been cancelled or that the voter by whom the appointment has been made is no longer entitled to vote, shall be guilty of an illegal practice within the meaning of *The Nova Scotia Elections Act* and shall incur a penalty of \$200, and shall be imprisoned for six months.

33. (1) The powers contained in an appointment of a proxy under this Part shall terminate upon the casting of the vote by the proxy, provided however that the extra-provincial active service voter may at any time thereafter appoint a proxy under the provisions for any subsequent election to the Assembly;

(2) Where a person who has appointed a proxy under this section ceases to be a member of the Forces or where such person cancels such appointment in writing the appointment of such proxy shall be null and void and shall not be used.

34. Except as otherwise provided by Chapter 14 of the Acts of 1945, the provisions of The Nova Scotia Elections Act and The Provincial Electoral Franchise Act, 1945 shall mutatis mutandis apply to these Regulations and the voting thereunder.

## PART III

## **Transfer of Active Service Voter**

**35.** (1) If between registration and the day for the holding of the polls an active service voter is transferred to or is on leave in a Polling District established by the Special Returning Officer other than that in which he or she is registered such active service voter shall be entitled to vote in such other Polling District on producing to the presiding officer at such Poll a certificate of such registration in the following form, the said certificate to be signed by the Registrar appointed for the Polling District in which such active service voter is registered:

(2) If there be no such poll established under The Active Service Voters Act in the Electoral District in which he was resident at the time of enlistment or enrolment and the person receiving such transfer has been discharged from the service or is on leave therefrom he may present such transfer to the Revising Officer for the Electoral District or additional Revising Officer, as the case may be, in which he was so resident and such Revising Officer upon being satisfied as to the facts and that the name of the applying active service voter is not on the list, shall enter his name upon the list for the appropriate Polling District; and, if the lists have been printed and certified to by him, such Revising Officer shall endorse on the transfer a certificate to the following effect:

"Certified as being qualified to vote under Section 35 of the Regulations in Polling District No.....

and signed by him as Revising Officer.

The active service voter on producing the transfer so endorsed to the Presiding Officer of the Polling District therein mentioned, shall be entitled to vote at such poll and the official list of voters shall for all purposes be taken to have been amended in accordance with such certificate.

(3) The Presiding Officer shall retain any such transfers as provided in sub-sections (1) and (2) of this Section and shall remit the same to the Returning Officer for such Electoral District.

36. An extra-provincial active service voter who, between the date of the writ of election and the day for the holding of polls, has been unable to comply with the provisions of Part II of these Regulations and has not appointed a proxy to vote for him in said election may apply to the Revising Officer of the Electoral District in which he was ordinarily resident for at least two months immediately preceding the day on which he became qualified as an active service voter to be entered on the list of voters for said Electoral District. The Revising Officer upon being satisfied as to the right of the applying extra-provincial active service voter to vote and that he has not appointed a proxy, shall enter his name upon the list for the appropriate polling district; and, if the lists have been printed and certified to by him, he shall issue a certificate in the following form to such extra-provincial active service voter who, on producing the same to the Presiding Officer of the Polling District therein mentioned, shall be entitled to vote at such poll and the official list of voters

shall for all purposes be taken to have been amended in accordance with such certificate. The Revising Officer shall, at the same time, send a duplicate of such certificate to the Presiding Officer concerned and to each of the candidates officially nominated, or their representatives.

**Revising** Officer

37. (1) For the purpose of the Active Service Voters Act, 1945, and for the purposes of any or all of these Regulations, the Revising Officer appointed under the provisions of The Electoral Franchise Act, 1945, may, and whenever the Provincial Secretary authorizes or directs shall, appoint one or more persons to act as additional Revising Officers for any Polling District or Districts within such Electoral District and such additional Revising Officer shall exercise all the powers and perform all the duties of the Revising Officer. Every such appointment shall be in writing and a duplicate thereof shall be sent by the Revising Officer to the Provincial Secretary forthwith after the making thereof.

(2) Any such additional Revising Officer shall before acting as such be sworn to the faithful performance of his duties before a Judge of any Court, a Notary-Public, a Stipendiary Magistrate, a Justice of the Peace or a Commissioner of the Supreme Court. (3) Where the Revising Officer for a County or Electoral District after he has appointed an additional Revising Officer to act for him under the provisions of the Electoral Franchise Act, 1945, becomes ill and is unable to act, the Returning Officer for the said County or Electoral District may, and, whenever the Provincial Secretary authorizes or directs, shall appoint the person or persons to act as the additional Revising Officers referred to in this Section.
