PAY AND ALLOWANCE REGULATIONS, 1914. AMENDMENTS.

Article 222 is hereby cancelled, see Article 565.

G.O. 68 1917.

Article 223 is hereby cancelled, see Article 560.

Article 224 is hereby cancelled, see Article 573.

Article 225 is hereby cancelled, see Article 574.

Article 227. Line 7, for "522" read "560".

Article 245 is hereby cancelled.

Article 560 is hereby cancelled and the following substituted therefor: from July 1st, 1917:—

"Travelling and Subsistence Allowance, for "limited periods of necessary absence on duty "from their stations, will be paid to Officers, "Warrant Officers, Non-Commissioned Officers "and Men at the following rates, subject to the

"restrictions and qualifications contained in "Articles 560 to 574.

Substantive Rank.	For absence of full period of 24 consecutive hours.	After 15 days in one place and not exceeding 3 months.
Major-General Brigadier-General	\$8 00	\$5 00
LtColonel	\$6 00	\$4 00
Captain Lieutenant	\$5 00	\$3 50
Warrant Officer	\$3 50	\$3 00
N.C.O's not below rank of Sergeant	\$2 50	\$2 50
Rank and File	\$2 25	\$2 00

"(1) The above rates of Travelling Allowance "for a full period of 24 hours absence, and are "intended to cover all expenses for hotel accom-"modation, meals and any other charges except "those under Article 569 and Railway and Steam-"ship transport, hire of horses, liveries or cabs, "when necessarily employed, and allowed."

"(2) Drivers of motor cars, when absent from their station on duty with their cars for 24 hours or over, may draw the Travelling Allow-"ance."

"(3) During the period an Officer, Warrant "Officer, Non-Commissioned Officer or Man is "absent from his station on duty, he will be entitled "to the above mentioned allowances, if obliged to "provide his own accommodation."

"(4) While in camp allowances will be paid in accordance with Part VII, Section 9, of these Regulations."

General Orders (Instructions, Regulations, etc.)-continued.

"(5) While detached for duty in England or "abroad, allowances will be paid in accordance "with Part VI, Section 2, of these Regulations."

(6) After three months on the lower rate of "subsistence any Officer, Warrant Officer, Non-"Commissioned Officer or Man, if detained in any "one place for a longer period, will receive only "his Ordinary Allowances."

Article 561 is hereby cancelled.

Article 565 is hereby cancelled, and the following substituted:—

"Officers, Warrant Officers, Non-Commissioned "Officers or Men of the Permanent Staff or "Permanent Force, detached from their regular "station for temporary duty elsewhere, including "those under instruction in England, may continue to draw the allowances they are entitled to at their station or, if in public quarters, his "family may continue to reside therein and "receive allowances in kind."

Insert new Article No. 573 (formerly No. 224), as follows:—

"Any cases not provided for in the foregoing "Regulations, and being deserving of special "consideration, will be referred to Militia Head-"quarters by the Officer Commanding the "District, for the approval of the Honourable, "the Minister, under the provisions of Article "563."

Insert new Article No. 574 (formerly No. 225), as follows:—

"Upon a change of station, if the family of an "Officer, Warrant Officer, Non-Commissioned "Officer or Man on the Married Establishment, "cannot accompany him on account of illness "certified to by the proper Medical Authority, he "may draw the same allowances as he would be "entitled to under Articles 560 (lower rate) and "565, but the additional allowance under Article "560 (lower rate) is to cease immediately the "Medical Officer certifies the family can travel."
