## Seventh 'Annual Convention, Manitoba Command A Great Success

If the elements of a successful convention compose increase in membership, and delegates in attendance, coupled with added efforts on the part of all committees, as shown in the work accomplished during the year, then it can be said that from the point of view of progress that the Seventh Annual Convention of the Manitoba Command was the most progressive in our history.

Sixty delegates were present, exclusive of fraternal representatives from our own and other veteran organizations, and a fine spirit of cooperation prevailed all through the proceedings. There was a distinct absence of any disposition to bicker over fine points and technicalities, and an earnest desire to do the best possible for the Association as a whole, and for its great principles.

The Convention was held in the London Block and got away to a good start shortly after 10 a.m., Feb. 11th, and closed at 6.30 on the 13th; packing in three days a good deal of constructive work, and a pleasant round of social events.

Following the "Silent Tribute" to the dead, short addresses of welcome were delivered by the Honorable John Bracken, Premier; General H. D. B. Ketchen; Mrs. R. A. Rogers, M.L.A.; Major F. G. Tayor, M.L.A.; and Mrs. Colin H. Campbell, I.O.D.E.

Fraternal greetings were presented by representatives of the following organizations: Naval Veterans, Imperial Veterans, Army and Navy Veterans, Amputations' Association, Tubercular Veterans, Grand Army of United Veterans, the Red Cross, and by Major McPherson, representing the Saskatchewan Command, G.W. V.A.

Comrade A. Irwin, a past Provincial President, also expressed his personal wishes for the succes of the assembly.

Every effort was made by the Entertainment Committee to provide for the leisure hours. As in past years the Ladies' Auxiliary provided a splendid luncheon to the delegates which was served in the assembly hall. The ladies were also hostesses at the whist drive and dance held on the night of the 11th. Thursday evening the delegates were the guests of the city of Winnipeg at a banquet in the Marlborough Hotel, which was followed by a theatre party to the "Originals" in "Stepping Down," at the Walker Theatre. On Friday the Winnipeg Branch entertained at a smoking concert, the programme being thoroughly enjoyed. At this event Past President E. E. Spencer made the presentation of the framed group photos to the Winnipeg Branch Football Team, which had so greatly distinguished itself in the past season. The St. Vital Branch Glee Club paid a surprise visit to the smoking concert and this talented band was accorded repeated encores.

The main resolutions adopted, together with other reports are published in this issue. Of course the main objective is to secure the passage of the legislation adopted by the Commons at last session, and rejected by the Senate, and for other recommendations of the Ralston Commission, which have not yet had consideration by Parliament.

Your Executive trust that from the committee reports which will be submitted to you, together with the report of your secretary, it will be found the duties of this Command office during the recess from the last Convention have been diligently performed, and that the trust reposed in us by the last Convention has been faithfully discharged.

Apart from the regular administration of the Command, members of the Executive have, with as little expense to the Command as possible, interested themselves in the revival of branches, which for numerous reasons, had failed to function. There have been gratifying results. Manitou Branch was re-organized last summer and is represented at this Convention. Pilot Mound has been visited and promises to be an active branch, as do other branches to which reference is made in the report of the membership committee.

The organization has increased its membership at least 10 per cent. in the past year. We might ask for a reason, and the answer is undoubtedly this; the unselfish spirit of service which characterizes our efforts, and the diligent care of the interests of the dependents and disabled, together with untiring efforts to protect their needs. This merits the support of the returned men and is receiving recognition by them, as made manifest in our new membership.

Our measure of satisfaction is

found in that we have the sympathy, the confidence and the respect of the public generally for our objects, and in our efforts to accomplish them.

The social side of the organization has found expression through your Command office in the concert party which has with such great success toured a large part of the province, as well as the territory in Western Ontario, which has been added to our jurisdiction. Of this concert party we may feel justly proud, as reports from all points where they have visited express the highest appreciation for the class of entertainment produced by them. Excellent results may be expected and social ties where this party brings together citizens and returned men for a social evening.

I feel that I should not let the opportunity pass of expressing my gratification upon the advance made by branches under this Command in the realm of sport during the past year. It is particularly pleasing to learn that the Winnipeg Branch Football Club succeeded in winning the championship of the Second Division, Winnipeg and District Football League, thus qualifying for promotion during the next season, and also were the winners of the Lewis Cup, which is now in the possession of the Association.

Strong activity has also been shown in Winnipeg in billiards, lawn bowling, carpet bowling and other sports, and the efforts of the participants have redounded much to the credit of the organization as a whole. It is pleasing to learn that in the Ten Pin Bowling League, entered into by the Winnipeg Branch, in the Mercantile League, it finished the series in second place and will be eligible for the final playoff this spring.

Reports indicate that branches throughout the province, and particularly in the city of Brandon, are taking a strong interest in sports and I can only personally express my belief that much good to the Association as a whole can be accomplished in this manner, and on behalf of the Command, I can assure branches of every possible support.

You will find much to occupy your attention during the Convention, and whilst an extensive social programme has been arranged, it is hoped that those questions which call for consideration will be dealt with by you with wisdom and diligence, so that from your efforts the result of this Convention may have the widest possible influence for the good of those whom we serve and that we may continue to command the respect and confidence of the public, whose sympathetic support we must at all times enjoy.

Your Provincial Secretary presents herewith a report on the progress of the Command and the work for the year 1924.

Changes and Resignations in the Executive: At the Executive meeting of July 20th the resignation of Comrade James Law from the Executive of the Command was accepted by the Executive. In December Comrade Day, of Roblin, left to take a position

in England and tendered his resignation, which was accepted by the Executive at their meeting on December 21st. Comrades H. J. Anderson and F. Scrase were then called to fill the vacancies.

Executive Meetings: Full meetings of the Executive were held on the following dates: March 1st, 1924, July 20th, 1924; December 21st, 1924; February 10th, 1925.

Resident Members' Committ met on the following dates: March 29th, 1924; April 14th, 1924; June 27th, 1924; July 13th, 1924; July 18th, 1924; September 2nd, 1924; September 16th, 1924; September 22nd, 1924; October 28th, 1924; November 3rd, 1924; January 12th, 1925.

Attendance Report: Number of Executive meetings held, four; number of resident members meetings, twelve.

Organization: Considerable organizing work was done by members of the Executive and by your secretary since the last Convention, resulting in the re-organization of five branches. tails in connection with this work will be presented by the chairman of the Membership Committee, but it should here be mentioned that Comrades Baldock, Cairns, Johnston, Rumer, the president, Comrade Spencer, and your secretary, have had the privilege of visiting 18 country branches during the past year. It is interesting to note the very hearty reception accorded by all branches to the Manitoba Command Concert Party, which has visited twenty towns since December 1st under the direction of the Command. This company of musicians has already proved its value as an organizing agency, and it is to be hoped that their tours will be con-

Work of the Provincial Executive: Probably the most important meeting of the year was held in July at the time the Senate rejected or mutilated the bills passed by the Commons. After a session lasting from morning until late at night the following statement was handed to the press by the Publicity Committee, and this statement clearly reflects the attitude of the Executive:

the Executive:

"At a meeting of the Provincial Executive, G.W.V.A., held yesterday, the action of the Senate in killing the Canteen Funds Bill and destroying in effect the Pension Amendments, received serious consideration. The news came as a shock to the officials of the Association who have labored for several years to bring into effect the much needed legislation recommended by the Royal Commission, and adopted by the Parliamentary Committee, and approved by the Commons for the relief of many thousands of war victims.

"The action of the Senate, coming as it does immediately following the recent assurances given by the Government, strikes a cruel blow to those unfortunate individuals for whose benefit, as clearly expressed by the will of the people through their duly elected representatives, the legislation was inteded. The Executive are authoritatively informed that not only did the Senate arbitrarily and with-

out any attempt at investigation, kill the legislation, but subsequently did not see fit to participate in a conference proposed by the House of Commons on 'such a bill.'

"Following upon a similar experience last session, the G.W.V.A. is forced to the conclusion that our present system of government is not consistent with the principles of democracy for which so many of our comrades laid down their lives, so many were maimed, and so many dependents were left in distresses.

"The G.W.V.A. has no intention of relinquishing the fight for this legislation and will continue its efforts even to the extent of embarking upon a nation-wide campaign for a drastic reform of the Senate, and will affiliate itself with the many other sections of the suffering public who hold similar views. The G.W.V.A. is of the opinion that the time has now passed when legislation erpressing the undoubted will of the people can be made subject to the autocratic veto of an un-elective and unnecessary body. It is anticipated that the question of Senate reform will now become a vital question with the veteran organizations, and the public will be asked for their support."

The Honorable Robert Rogers, who has from time to time assisted your executive in arranging meetings with the Senate and others, kindly arranged for members of your Command to meet Sir James Lougheed, leader of the Conservative party in the Senate, and on September 21st Comrades Johnston, Rumer, Bowler and your secretary met Sir James at the Royal Alexander Hotel. Senator Lougheed excused the action of the Senate on the grounds that the legislation had not been brought to the Senate in

time. After members of the delegation had briefly pointed out to him the need for the legislation and has discussed certain points of the Pension Act with him, he promised his support at the next session.

Delegates from the Provincial Command also interviewed Sir Arthur Meighan and Premier McKenzie King during the course of the year. Mr. Meighan admitted that certain matters brought to his attention by the delegation were new to him, particularly in reference to the jurisdiction of the Appeal Board, but he justified the Senate in its action by offering the same reason as Sir James Loug-heed. Premier McKenzie King was not willing to commit himself on any of the points raised, in the absence of Dr. Beland, Minister of the D.S.C.R., but he did not hesitate to state that his Government would introduce a policy of Senate reform. He pointed out that the Government had passed the legislation unanimously but that the Senate had seen fit to amend or destrop it. No doubt these interviews will bear fruit at the present session Parliament.

Royal Commission.—The fifth and final report of the Royal Commission was abled in the Commons since our last Provincial Convention. This report contains more than twenty-six definite recommendations for the benefit of disabled veterans and dependants, and there form the basis of our legislative programme for 1925.

Poppy Day Campaign—The Poppy
Day Campaign was conducted by
Comrades E. F. Neilson, J. V. Johnston, and your secretary. The committee introduced Poppy Day to the
pupils of all schools in the province.
In this work the committee was assisted by the Honorable Chas Cannon,

Minister of Education, and by the superintendent and staff of the Winnipeg School Board. A special programme was drawn up and sent out in pamphlet form to cover two thousand school teachers in the province. The results were very gratifying, the committee disposing of over 135,000 poppies to schools and branches in Manitoba. A full report in detail has been submitted to the Provincial Executive and will be brought to your attention in the Finance Committee report.

Personal Service Bureau Personal Service Bureau — As in previous years the Provincial Command has continued its work as a service bureau for all veterans and dependents. It is now six and a half years since the conclusion of hostilities but the Command office is still called upon to deal with new applicants for pensions and treatment, vocational training, war service grat-uity, and many other similar claims. The work has been lessened by the appointment of the Soldier Adviser, but the Command still has some 1,500 current files and during the past year over 5,000 letters have been mailed in connection therewith, while personal interviews have averaged personal interviews nave averaged ten a day. Adjustments obtained for tex-service men and dependents have reached the splendid sum of \$32,628.00, and it is well to remember that in addition to this amount, which was actually paid to the applicants, the various municipalities and the Provincial Covernment have benefited Provincial Government have benefited proportionately. For example, as a direct result of adjustments secured through the medium of the G.W.V.A. Provincial Command, in conjunction with the Soldier Adviser, the sum of

#### **OUR TASK AT THIS SESSION**

A T the Manitoba Provincial Convention of the G.W.V.A. stress was laid on the necessity of providing for the re-introduction of the defeated Pension Amendments, together with the recommendations contained in the fifth report of the Ralston Commission, at the earliest possible date during the present session of the Federal House.

It was the general opinion that this legislation contained the most vital pallatives for the relief of the disabled and dependant, and that the efforts of the G.W.V.A. and Veteran bodies generally should be concentrated on their early consummation.

The incorporation of the bonus as a permanent part of the pension is an outstanding measure, which will relieve the anxiety of the many hundreds; and the loss of which would be followed by acute distress. This bill has already passed the House of Commons and now requires only the sanction of the Senate to make it law.

Other amendments to the Pensions Act, which will straighten out existing anomalies,

obviously never intended in the original drafting of the act, must also be dealt with.

Amendments to the Soldier Settlement Act, aiming to relieve the distress due to post war conditions, and war prices, with the consequent failure of the settler to meet his obligations, is another measure long overdue.

The extension of the powers of the Federal Appeals Board is not the least important matter for amending legislation. At present the Board is prevented from the exercise of functions which its very name and composition call for. These powers, such as hearing additional evidence, and of calling any witnesses who may throw any further light on the applicant's claim, are absolutely essential if the applicant is to obtain a square deal. Such powers indeed have always been exercised by similar boards in both Great Britain and the United States.

These questions and many more call for the earnest effort of all veteran organizations, and the co-operation of all will find reflection in the gratitude of those we seek to serve.

#### THE CANTEEN FUNDS BILL

THE BILL providing for the distribution of the Canteen Funds, will, in all probability be passed at this session.

The legislation provides for a pro rata distribution of the funds by provinces, and will be placed in charge of trustees (unpaid), who will be appointed by the representative veteran organizations.

The bill is strongly supported by ex-service men generally; as affording as fair and equitable a distribution as can be devised.

No scheme is possible that will please all veterans, but the bill as it stands will give the returned men of each province a voice in its disposition.

We trust no objections will be raised by small groups of ex-service men who, with the best of intentions, will only succeed in indefinately delaying the release of the funds.

It is noticeable that so far, the main objections to the provisions of the bill, come from gentlemen who had no personal concern in the canteens, were not purchasers, and consequently not shareholders.

The question is one for the contributing exsoldiers alone, and the logical expression of their views is through the combined veteran organizations, all of whom have approved the bill.

### SOLDIER SETTLERS NOT SOLD OUT—A CORRECTION

In our January issue we published a statement by Dr. J. A. Hunter, of the Teulon district, setting out the conditions of our comrades on the land in that vicinity. The doctor stated that a number of soldier settlers were being sold out.

The interview was given to the daily press, and we reproduced it in good faith, as coming from one with

a considerable standing in his community.

It appears that the facts, however, had reference to defaulters under the Rural Credit System, and the doctor wrote to the press some days later to this effect. We regret we did not notice the correction, which was only brought to our attention during the Manitoba Provincial convention.

We might add that the columns of the Manitoba Veteran are always

open for discussion of the difficulties of our Soldier Settler comrades, and to the Soldier Settlement Board.

It is expected that legislation for the relief of settlers will be passed at this session of the House, and we feel assured that the Soldier Settlement Board will give every assistance toward relieving a situation which is becoming impossible for many of the soldier settlers, who bought their land and equipment at a time when prices were at the peak.

approximately \$5,000.00 has been paid to the city of Winnipeg by the Federal Government to adjust hospital accounts previously held against individuals. Inasmuch as collection from the individuals concerned could not be, and was not expected, this money represents a direct gain to the city. Then again, every claim for pension established on behalf of men who are out of work or who may find themselves in that unhappy position, transfers the responsibility for the man and his family from the civic authorities to the federal authorities, where, in the case of the disabled, it rightfully belongs. The Provincial Government has also benefited by the efforts of the Command, particularly in respect to the Mothers' Allowance Act. Every widow's claim successfully established means a direct saving to the Mothers' Allowance appropriation. In this respect one adjustment alone refunded to the government an amount almost equal to the grant received by the Command from the Provincial Government last year. Mention should also be made of the many cases, as from time to time found necesary, which have been passed by the Command to the Soldier Adviser. These number more than two hundred, of which a considerable number have already been adjusted. Approximately \$15,000.00 has been recovered as a result of successful appeals of Command cases to the Federal Appeal Board. The Command has assisted the Soldier Adviser to the fullest possible degree in the preparation and presentation of all these cases, and has not deemed its duty complete until final disposition has been made. It will be seen, therefore, that the grand total of adjust ments directly or indirectly obtained by the Command in this way amounts to \$47,688.00.

I wish to acknowledge the assistance rendered by the various Ladies' Auxliiaries throughout the province, and in particular the ladies of the Winnipeg Branch, who have always been ready to visit out-of-town comrades in hospital, and have also assisted officials of the civic departments, the Red Cross and the D.S.C.R. is also gratefully acknowledged.

May I take this opportunity of expressing my sincere thanks to the president, and to all members of the executive for their help during the past year, and also to branch secretaries in all parts of the province, who have given their loyal support whenever called upon.

## REPORT OF THE MEMBERSHIP COMMITTEE

Your committee, composed of the following members, Comrades A. E.

Moore, J. W. Baldock, C. G. Whitehurst, W. A. Piper, E. F. Neilson, beg to report as follows:

During the year ending December 31st, 1924, forty-one branches in this province paid per capita tax, and of this number thirty are in good standing at this date.

As was mentioned in the report of your membership committe for 1923, an important phase of the Veteran movement in the province is the number of Veteran clubs which are functioning and are not affiliated with this, or any other organizationn. Your committee has a list of such clubs, and would recommend that every effort be made to bring these into the Association during the ensuing year.

Last year nine branches from Western Ontario were brought under the jurisdiction of this Command, and your committee regrets to report that three of these branches are already in arrears of per capita tax.

Two new charters to branches of this Association, situated at Selkirk and Elmwood, were issued during the year, this bringing the total number of charters issued in this province up to 80. As already stated, 41 branches have paid per capita tax during the past year, which shows that the command is only receiving revenue from approximately 50 per cent. of the branches under its jurisdiction.

In compliance with the recommendations contained in the membership committee report for last year—"that steps be taken to revive some 25 branches in the province which were apparently dead, and failing this to have their charters recalled"—several members of the provincial executive have visited certain of these branches during the summer with various degrees of success, as is shown in the following list of branches visited: Pilot Mound, Elmwood, Gladstone, Sperling, Souris, Morris, Beausejour, Roland, Carman, Selkirk, Kenora, Sprague, Port Arthur, Wawanesa, Giroux, Argyle, Manitou, Somerset.

In addition, it might be mentioned that the G.W.V.A. concert party is doing good work throughout the province as an organizing agency.

Per Capita Tax: Payments of per capita tax show a decided improvement, and indicates an increase in paid-up membership of approximately 10 per cent.

Your committee is of the opinion that a great deal has been accomplished during the year and that the present membership and benefits accruing from such will be lasting, as the returned men in most communities are more settled and appear to be gradually taking their place in the more important affairs of the community.

We would, therefore, recommend that the policy, as adopted last year, be continued, and that members of the incoming executive be alloted certain branches to visit and be responsible for the organization of these branches during their tenure of office, as we feel that personal supervision by the Provincial Command is of far greater benefit and much more effective than any amount of paper propaganda.

### LEGISLATIVE COMMITTEE REPORT

Mr. President and Comrades:

The Legislative Committee of the Command beg to submit the following survey of legislative matters affecting the interests of the Association during the past year. A discussion of these matters naturally falls under two headings: first, Federal Legislation; second, Provincial Legislation.

Federal Legislation: It is a matter of regret that very little advance was made on this question at the last session of the Federal Parliament. It is perhaps not generally known that a special committee of the House of Commons was appointed to consider the recommendations of the Ralston Commission Report and to hear evidence on behalf of ex-service men. The entire programme of legislation was presented to the committee by Comrade C. G. MacNeil, Dominion Secretary, in a most able manner, and as a result of the committee's enquiries a bill was passed by the House of Commons containing almost without exception the principles contended for by this Association. It is now a matter of history that the bill concerned was fatally mutilated upon reaching the Senate, and despite efforts to bring about a conference between the House of Commons and the Senate, the Senate amendments were allowed to stand. The principle points involved in the legislation are the following:

(1) Permanency of the Bonus: This was recommended by the parliamentary committee and passed by the House of Commons. The Senate amendment, however, simply extended the bonus for a further period of one year, so that as the matter stands at present the bonus wil automatically expire on the 31st of August,

(2) The Extension of the Jurisdiction of the Federal Appeal Board, to include cases other than attributability. This highly important measure, which has behind it the recommendation of the Ralston Commission and the approval of the House of Commons, still remains unaccomplished, due to the Senate amendments.

ments.

(3) The Proposed Amendment to Section 3 of the Pension Act concerning pension to widows married after the appearance of the disability resulting in death. The principle of the amendment proposed by this Association has on three successive occasions been approved by the House of Commons and also has behind it the recommendation of the Ralston Commission, but as is the case with the legislation referred to above, has been refused recognition by the Senate.

It should hereby be pointed out that a large number of other important measures recommended by the Ralston Commission in its fifth and final report have not yet been put into effect, and the Association should not relax in its efforts towards this end.

The amendments to the Pension Act actually accomplished at the last session of Parliament may be sum-

marized as follows:

(1) An amendment providing that the Pension Board shall on request provide a statement in writing over the signature of the Commissioner's dealing with the case, showing the ground upon which an award is refused is refused.

(2) An amendment clarifying the Statutory Bar in respect to new applications for pension.

An amendment concerning payment of pension to pensioners under arrest.

An amendment concerning payment of pension to cases considered specially meritorious, but otherwise ineligible.

amendment concerning retroactivation.

An amendment concerning pension to dependent parents.

An amendment providing for payment of pension to the dependents of a deceased pensioner for a period of one month pending consideration of the claim.

An amendment permitting reinstatement of pension to a widow who has remarried, but who within five years after remarriage again becomes wid-owed, and is left in adependent condition.

An amendment providing for the extension of the time for filing appeals for a period of

one year.

An amendment concerning the form judgments delivered by the Federal Appeal Board. In respect to more vital matters

referred to above and still unaccomplished, your committee observed that resolutions will be brought before this Convention reaffirming the stand taken on previous occasions and providing for the presentation of a petition calling upon the government to re-introduce the rejected legislation at an early date during the present session.

The committee would be remiss if it failed to extend recognition to the Winnipeg Branch, G.W.V.A., for its splendid and unselfish efforts towards bringing into effect the required legislation. At the last session of Parliament, the Winnipeg Branch, entirely at its own expense, sent two of its officers, namely, Comrades Moore and Rumer, to Ottawa with a view to furthering the efforts of Comrade MacNeil and willingly consented that these comrades should represent not only the Winnipeg Branch, but should also carry the status of representa-tives from the Provincial Command

Provincial Legislation: It is pleasing to report that the efforts of the Command in this channel have met very largely with success. The enactments in respect to which the Command is particularly interested are:

(1) The War Relief Act,
(2) The Soldiers' Taxation Relief Act.

Act. War Relief Act: As a result of the representations made during the last session of the Provincial Legislature the War Relief Act was amended so that it remains in effect until repealed. Other amendments of a less important nature were also secured. The committee notes that a resolution is to be introduced to this Convention providing that should any attempt be made to repeal or modify the War Relief Act during the present session, any such attempt is to be opposed by the Provincial Command. The committee concurs in this suggestion.

Soldiers' Taxation Relief Act: The committee is pleased to report that amendments proposed by it last year with a view to clarifying certain defi-nitions were accepted by the govern-ment and became law. The result was that many cases previously barred immediately gained recognition. It has been found, however, during the past year that there is need for further clarification as to the parties entitled to the benefits of the Act. The committee believes that the Act was intended to grant relief to all disabled ex-service men, and the dependents of deceased or disabled ex-service men in respect to their homes. It has come to the knowledge of the committee during the past year that despite the care exercised during preceding years there are still a number of bona fide dependents who cannot receive the benefits of the Act. committee, therefore, have suggested an amendment providing that the rean amendment providing that the relief shall be extended to all persons recognized by the Board of Pension Commissioners or the Department of Soldiers' Civil Re-establishment and the British Ministry of Pensions dependents, and it believes that this amendment, if accepted, will eliminate discrimination in future. The ate discrimination in future. The committee would add that this proposal has been discussed with, and has received the approval, of the Legislative Committee of the Army & Navy Veterans in Canada.

A resolution covering the point in question will, it is understood, be brought before this Convention for consideration

Pensions (All Branches)

WHEREAS this Association has for several years past unanimously placed itself on record as agreeing that the present temporary bonus on the support of all other Veteran or-pensions should be incorporated as a permanent part of the basic pension rate, and

WHEREAS the G.W.V.A. has with the support of all other veteran or-ganizations, presented from time to time its views on this question to the Royal Commission and through the

medium of the Parliamentary Committee to Parliament, and
WHEREAS the Parliamentary
Committee of 1923-4 Session after
hearing representations made to it, and after considering the findings of the Ralston Commission and after investigating all facts pertaining to the permanency of the bonus unimously

recommended to Parlaiment that the bonus should be incorporated as part

of the permanent pension, and WHEREAS the House of Com-mons, after further consideration of the recommendations of the Committee, passed a Bill providing for such recommendations to be carried into

WHEREAS the said Bill upon being considered by the Senate, was mutilated so as to destroy the intent of the House of Commons and under the present provisions of the Act the

the present provisions of the Act the said bonus will expire on the 1st day of September, 1925, and WHEHEAS this Association believes that the amendment introduced upon the initiative of the Senate is contrary to the will of the people of Capacia and is contrary to the host Canada, and is contrary to the best interests of the disabled ex-service men and the dependents of deceased

soldiers,
NOW, THEREFORE, BE IT RESOLVED that we, the Manitoba
Command, G.W.V.A., in annual convention assembled, having regard to

#### Pensions: (Winnipeg Branch)

Be it resolved that Section 11 of the Pension Act be amended, further to the 1923 amendment, so as to provide for payment of pension to de-pendents (if otherwise eligible) in all cases where death is the result of a disability aggrevated by or during service.

#### 3. Pensions (Winnipeg Branch)

WHEREAS the Royal Commission on Pensions in its report recommended that the decision of the Federal Appeal Board should be final, provided, however, that where subsequently evidence of a convincing nature should be produced a re-appeal should be allowed, and,

WHEREAS at the instance of the Senate this right was deleted from

the amendments proposed at the Session of Parliament and approved by

e Commons, and WHEREAS the difficulty and uncertainty in procuring evidence as to the origin or continuity of war ser-vice disabilities is well known and in many cases the evidence in support of a pension claim must necessarily

be incomplete, and,
WHEREAS it is manifestly unjust
to deny the right of a further hearing should the evidence subsequently

ing should the evidence subsequently become available,

THEREFORE, BE IT RESOLVED that we, the Manitoba Command, G.W.V.A., in annual convention assembled, do hereby go on record as requesting the Federal Parliament to re-enact without delay the provision referred to in the first paragraph bareof hereof.

Pensions

WHEREAS it is provided by the provisions of the Pension Act that appeals shall lie to the Federal Appeal Board only upon the same evi-

dence and record upon which the Board of Pension Commissioners gave their decision, and

WHEREAS this has been construed where As this has been constitued in practice to mean that no evidence even that of the applicant himself, can be taken by the Appeal Board, who are confined solely to the documentary evidence on file, thus rendering the appearance of the applicant of the appli

cant or any other person of no avail, except for the purpose of argument, AND, WHEREAS it is pointed out that the Board of Pension Commissioners through the medium of the District Offices, have the opportunity to hear, and invariably do hear, the viva voce testimony of the applicant himself and frequently that of other witnesses, which testimony, however, is not recorded in extenso on the file, but is usually summarized by some other person; further, that the Board of Pension Commissioners frequently act upon the hearsay evidence of third parties, which is not taken under oath and which is not fully re-corded on the file; and, further, that the Board of Pension Commissioners are enabled to take evidence of any additional witness they deem advisable and necessary

THEREFORE WE, the G.W.V.A., Manitoba Command, in annual convention assembled, do go on record as helieving that in the interests of justice the Federal Appeal Board should have the same powers as to hearing evidence as have the Board of Pen-sion Commissioners, and do request sion Commissioners, and do request the Federal Parliament to enact legislation that will enable the Appeal Board to take and act upon any evidence deemed material to the claim that may be brought before them.

5. Winnige Branch

WHEREAS during the sittings of the Royal Commission on pensions and re-establishment the necessity for the appointment of an Appeal Board to adjudicate upon decisions of Board to adjudicate upon decisions of the Board of Pension Commissioners as to pensions, and the Department of Soldeirs' Civil Re-establishment, as to treatment was fully demonstrated, AND. WHEREAS, upon hearing the evidence presented to it through-out Canada the said Commission rec-

ommended to Parliament the appointment of such Appeal Board with power to adjudicate upon any decision of the Board of Pension Commissioners, or Department of Soldiers' Civil Re-establishment, thus 'ollowing the established practice of Great Britain, the United States, and all the principal allied countries.

AND, WHEREAS, legislation embodying the above was submitted to the House of Commons at a recent session of Parliament and approved, and later, at the instance of the Senate, the jurisdiction of such Board of ommended to Parliament the appoint-

ate, the jurisdiction of such Board of Anpeal was seriously curtailed so that at the present time it can only deal with cases where the relationship of disability to military service is in dis-

WHEREAS, to our certain knowledge there are a large number of cases throughout Canada in respect to which points other than the relationship of disability to service are in dispute, but by reason of the limitation above referred to, the person affected have no right of appeal whatAND, WHEREAS, we are of the opinion that the aim of the Royal Commission in recommending the institution of an Appeal Board has been thus defeated to a material extent, and that a large proportion of the grievances intended to be rectified

still remain,
NOW, THEREFORE, we, the
Manitoba Command, G.W.V.A., in
annual convention assembled, do hereby place ourselves on record as requesting the immediate introduction of legislation to restore the jurisdiction of the Appeal Board to the original intent thereof, and agree that the Federal Government shall be that the rederal foretries of the control of forthwith memorialized to this effect.

#### Winnipeg Branch

WHEREAS, at the Session of the Federal Parliament, 1921-22, an amendment was passed by the House of Commons to Section 33 of the Pension Act, based upon recommenda-tions of the Parliamentary Committee on pensions at that session, providing for payment of pension to the widow of any soldier dying from a pension disability, where the marriage took place prior to one year from the date of the soldier's discharge.

AND, WHEREAS, at the instance of the Senate, such amendment was eliminated,

AND, WHEREAS, at the Session of Parliament 1922-23 such amendment was again passed by the Commons and at the instance of the Senate was again eliminated.

AND, WHEREAS, we are of the opinion that the necessity for such amendment has been abundantly amendment has been abundantly proved in that many marriages were contracted after discharge in good faith and without knowledge of the existence of the war disability which subsequently caused death, in all of which cases pension is now denied by reason of the elimination of such amendment

amendment.

AND, WHEREAS, we believe that the widows in such cases are justly entitled to pension,

AND, WHEREAS, at the 1923-24 session of parliament a further amendment based on the recommendation of the Ralston Commission and containing ample safeguards against fruade or abuse were passed by the committee, but were again rejected by the Senate.

AND, WHEREAS we are of the opinion that the safeguards proposed by the Ralston Commission provide an effective bar against claims arising from fraudulent or death-bed

marriages,

THEREFORE, we, the Manitoba Command, G.W.V.A., in annual convention assembled, do hereby urge upon the Federal Government the desirability of again introducing such legislation, and we urge that strong representations be made to the Senate as to the real necessity for its enactment.

#### 7. Pensions (Imperial) St. James Branch

WHEREAS, there are members of the Imperial Forces ex-service men who are members of the G.W.V.A.,

WHEREAS, there are numbers of these men who are in receipt of Im-perial pensions and who are penalized

by a low rate of exchange when the money market fluctuates,
NOW, BE IT THEREFORE RESOLVED, that any man in receipt of a pension whether Imperial or otherwise, should receive the amount of this pension in Canadian currency payable at par payable at par.

#### All Branches

Whereas, as a result of evidence presented by the G.W.V.A. and other veteran organizations to the Federal authorities during the past year the question of the re-organization of the Board of Pension Commissioners, by reason of their unsympathetic at-titude towards ex-service men and their dependents, was considered by a special parliamentary committee, AND, WHEREAS, the report of the committee, after hearing all avail-

NOW, THEREFORE, BE IT RESOLVED, that we, the Manitoba Command, G.W.V.A., in annual convention assembled, believing that the reorganization of the Pension Board is vitally necessary in the interests of the country and ex-service men to allay the present pronounced unsatis-

faction and unrest,
IT HEREBY FURTHER urges the
Parliament of Canada to give effect
to the recommendations of the said

committee without delay.

#### Pensions (All Branches)

WHEREAS it would appear from the public statements of the Honorable Members of the Senate of Canada that it is desirable in the public interests that all amendments to the Bills effecting Soldier Legislation be brought down early in the Session of 1925, and

WHEREAS, it would seem that this request is reasonable,

THEREFORE, BE IT RESOLVED. that we, the Manitoba Command, in annual convention assembled, request the Dominion Secretary of the G.W. V.A. to present a petition to His Excellency the Governor-General-in-Council, praying him to cause to be laid before Parliament all clauses of the Soldiers' Pension Act amending bill, as were passed by the House of Commons, and rejected by the Senate, as soon after the assembling of the House of Parliament as is possible. and be it further resolved that the Dominion Secretary be requested to acquaint all branches of the G.W. V.A., with the answer of the Gover-nor-General after the petition has been presented.

#### 10. D.S.C.R. (Winnipeg Branch)

WHEREAS it has been brought to the notice of this Association that pensioners or applicants for pension or treatment, upon being called in by the D.S.C.R. Pension Board for examination, are. if unemployed and residents of Winnipeg or District, discriminated against in the matter of allowances during the period of attendance for and during examination. tendance for and during examination,

in that ex-soldiers in employment can obtain the specified remuneration upon production of their employer's certificate, whilst ex-service men employed receive no remuneration whatsoever.

AND, WHEREAS, it is the opinion of this Association that disabled ex-service men unemployed are in equal, if not greater, need of remuneration than those in employment,

THEREFORE, BE IT RESOLV-ED, that in the opinion of the Manitoba Provincial Command, G.W.V.A., in annual convention assembled, the discrimination set forth above is unfair and unwarranted, and we do hereby request that steps be taken to re-adjust the allowances to unemployed and employed ex-service men upon an equal basis.

#### Soldier Settlement Board (All Branches)

WHEREAS certain resolutions dealing with the difficulties of Sol-dier Settlers and proposed remedies WHEREAS therefor were exhaustively presented through the medium of the G.W.V.A. to a special committee of the House of Commons during the sessions of 1923-24,

AND, WHEREAS, the report of the said committee recommended to Parliament as follows:

(1) That the Soldier Settlement Board shall immediately make provision for reduction on the provision for reduction on the price of all live stock advanced to Soldier Settlers, and purchased prior to the 1st of October, 1921, as follows:

(a) If such live stock was purchased provisions to the 1st of Octobers.

chased previous to the 1st of October, 1920, a reduction of 60 per cent. of the purchase

60 per cent. of the purchase price thereof.
(b) If the said live stock was purchased after the 1st of October, 1920, and previous to the 1st of October, 1921, a reduction of 40 per cent. of the purchase

price thereof.

That the period of interest exemption provided in Section 1 of the amendments to the Soldier Settlement Act of June 28th, 1922, be extended until the 1st of October, 1933.

Your committee further recom-

mends that, in the event of any mends that, in the event of any pre-payment of principle the Soldier Settlers shall be entitled to, and shall receive a discount at the rate of 5 per cent. per annum from the date of such prepayment to the due date of prepayment to the due date of such prepayme same, but this discount privilege shall not extend beyond the 1st

of October, 1934. Your committee further recommends that the Soldier Settlement Board shall have discretionary power to re-locate bona fide Soldier Settlers who are found to be located upon manifestly unsuitable farms; such relocation to be made without financial loss to the settlers.

If, after the interest exemption period, provided for herein, expires a capital loss is clearly indicated the question as to whether the Government shall bear the whole or part of the loss can then be determined, and if

decided affirmatively appropriate action can then be taken for a re-adjustment on any install-

ment remaining unpaid AND, WHEREAS, this Convention believes that the adoption of the committee's recommendations will provide a solution to the present obstacles to the successful administration of the Soldier Settlement Act,
AND, WHEREAS, it has been brought to the notice of this Association that none of the said recommendations have yet been acted upon by believes that the adoption of the com-

dations have yet been acted upon by

Parliament.

NOW, THEREFORE, BE IT RE-SOLVED that we, the Manitoba Provincial Command, G.W.V.A., in annual convention assembled, heartily concurring in the committee's report, do urge upon the Federal Government the necessity for the immediate adoption and application of the said recommendation.


