No New Restrictions on Travel to Canada

Visitors from the United States may enter Canada freely and move about with the same informality and ease they experience in their own land. No new restrictions have been imposed, or are likely to be imposed, on the personal entry of tourists from the United States into Canada. American tourists and visitors are cordially welcomed to Canada and do not require passports to enter the Dominion.

In order to facilitate crossing the International Boundary in both directions, citizens of the United States by naturalization should be prepared to present their naturalization certificates, and citizens of other countries should be prepared to establish their legal admission to the United States either by record of admission or certificate of reentry. Citizens of enemy countries will, naturally, be subject to restrictions but these will not affect the movement of tourists from friendly or neutral countries, who will continue to be welcomed as they have been in the past.

Returning to the United States

THE United States Department of State advises that, "The new (United States) regulations impose no additional requirements on United States citizens and they may, as heretofore, proceed to Canada and return to the United States without any specified documentation. They need have only as a matter of convenience the documentary evidence customarily carried in the past."

Bona fide American citizens should have no difficulty through answers to questions and otherwise in satisfying the Examining Immigration Officer. In case they are asked to show papers to establish their identity and place of residence, the possession of personal papers or other identifying documents would be helpful; for example, old passport, birth or baptismal certificate, voter's certificate, tax bills, letter of identification from a bank manager or responsible municipal official, personal letters, car licence, driver's licence or similar papers.

It is suggested that naturalized citizens carry with them their naturalization certificates.

Citizens of other countries, including Canadian citizens, who are permanent legal residents of the United States, should secure

a reentry permit from the United States Immigration and Naturalization Service before departing from the United States. Application for a reentry permit should be made approximately 30 days before departure. The fee for a permit is \$3 and a separate application must be made for each person. A reentry permit is valid for only one year and may be used for only one entry to the United States. Should such a citizen leave the United States without a reentry permit, a new immigration visa, involving fees and documents, must be secured from the United States Consular Authorities before he can re-enter the United States.

Persons who visit Canada frequently should apply to the nearest office of the United States Immigration and Naturalization Service for a border identification card.

No Changes Regarding the Admission of Tourists' and Sportsmen's Outfits into Canada

Tourists may bring into Canada their automobiles, personal effects, tourists' outfits, such as cameras, golf clubs, camp equipment, fishing tackle, guns and rifles, etc., without

payment of either duty or deposit. (A permit for the admission of firearms must be obtained beforehand from the Commissioner of the Royal Canadian Mounted Police.)

Tourists may take out, or have sent to them after they leave Canada, any goods purchased in Canada for personal or household use. (Under the United States tariff regulations, residents of that country returning from Canada may each bring back, free of duty, articles of Canadian merchandise aggregating up to \$100 in value acquired for personal or household use or as souvenirs, provided they have remained in Canada not less than 48 hours.)

Exchange Premium Benefits United States Tourists

Visitors to Canada will benefit by a favourable exchange rate. A premium exists in Canada on United States dollars, and the Foreign Exchange Control Board has made it obligatory that Canadians accepting United States currency in payment for goods and services must pay the premium. The rate is widely quoted in the daily news-

papers throughout the Dominion, or can be had from any of the 3,300 branch banks.

The United States visitor is thus, by Canadian law, assured of the official rate of exchange on his currency while in Canada.

It is not necessary to worry about exchange problems. They do not exist. The tourist may exchange his currency after he enters Canada, as a matter of convenience, or he may use his United States currency as his journey proceeds or as his needs arise. If a tourist has any reason to doubt the rate tendered, he has only to go to a branch bank and the official rate will be available and paid.

As a convenience to departing United States tourists, branch banks and rail-way ticket offices are permitted to convert, at official rates, residue amounts of Canadian currency into United States currency to a total of \$20.
