FINANCIAL INSTRUCTIONS AND ALLOW- ANCES FOR THE CANADIAN EXPEDI- TIONARY FORCE, 1916.

AMENDMENT.

Article 123a is cancelled and the following substituted **G.O. 88**
therefor with effect from June 1, 1917. 1917.

Notwithstanding any regulations which may be issued from time to time, regarding harvesting and seeding furloughs to be granted to Non-commissioned officers and men of the C.E.F., pay and allowances or traveling expenses are not to be granted, and the Government will not be responsible for any accident or illness which may occur during such furlough.

Reserve of Officers.

1 Authority is granted for the formation of a Reserve of Officers, Canadian Expeditionary Force.

2 The said Reserve will consist of officers, who, having served with credit in the Canadian Expeditionary Force, cease or already have ceased to be employed therein.

3 Such officers will retain in the said Reserve the rank and seniority which they hold or held in the Canadian Expeditionary Force when they cease or ceased to be employed therein; subject to the proviso that their status in the Canadian Militia will not thereby be affected.

4 They will be the first to be considered for appointments which they are qualified to fill, and preference will be given to those, who during the present war, have taken part in active operations.

5 Reserve Officers of the Canadian Expeditionary Force are not entitled, as such, to pay and allowance.


