HEADQUARTERS, OTTAWA,

15th September, 1917.

INSTRUCTIONS, REGULATIONS, ETC.

MILITARY FUNERALS FOR MEMBERS OF THE CANADIAN EXPEDITIONARY FORCE, DYING IN CANADA, BEFORE AND AFTER DISCHARGE.

1. In cases of deaths in Canada of members of the C.E.F., when no C.E.F. unit is available, Military funerals including escort and firing party, should be furnished by a local unit of the Active Militia, if one is available—if necessary at the public expense, when so recommended by the District Officer Commanding. **G.O. 92**

2. For the duration of the war, in cases of death of ex-members of the C.E.F., in Canada, who have seen Active Service Overseas, and have been honourably discharged, and requests are received for Military funerals, the necessary escort and firing party may be furnished by a local unit of the Active Militia, when no C.E.F. unit is available, without expense to the public.

ORGANIZATION.

MILITARY POLICE (C.E.F.).

1. Authority is granted for the formation of Military Police, the detachments of which will form part of the Canadian Expeditionary Force. **G.O. 93**
1917.

2. With reference to General Order 93 (1) 1917, the organization of detachments of the Military Police, with headquarters in each Military District, is authorized. The designation of these detachments will be "Military Police, C.E.F."

CALLING OUT TROOPS ON ACTIVE SERVICE.

In virtue of Orders-in-Council by His Royal Highness, the Governor General in Council, P.C. 2067 and P.C. 2068, dated 6th day of August, 1914, the organization of the undermentioned unit of the Canadian Expeditionary Force is authorized, in addition to the units mentioned in G.O. 36 of 1915, G.O. 86 of 1915, G.O. 103a of 1915, G.O. 151 of 1915, G.O. 69 of 1916, G.O. 11 of 1917, G.O. 63 of 1917 and G.O. 74 of 1917, and said unit is placed on Active Service from date of its organization:—

Military Police.

COMPOSITION OF THE CANADIAN EXPEDITIONARY FORCE.

General Order 28 of March 15th, 1917, is hereby cancelled and the following is substituted therefore:—

The Canadian Expeditionary Force is composed of the following classes of the Canadian Military Forces, viz.,—

1. Those officers, non-commissioned officers and men, who, during the present war, are serving outside of Canada, but in the pay of the Dominion Government.

2. Those officers, non-commissioned officers and men, who, during the present war, are serving in Canada with units intended to be sent overseas.

3. Those officers, non-commissioned officers and men, who, during the present war, are serving on, or attached to the Headquarters' Staff or the staffs of Military Districts, or the Military Instructional Staff of the Royal Military College of Canada.

4. Those officers, non-commissioned officers and men of the Permanent Force of Canada, who, during the present war, are employed on garrison duty in Canada, or on instructional duties in connection with the units to be sent overseas.

5. Nothing herein contained shall authorize or entitle the officers, non-commissioned officers and men mentioned in paragraphs 3 and 4 herein, to receive the special pay, allowances and pensions granted to the Canadian Forces serving overseas, but they shall continue to be entitled to such pay, allowances and pensions as are prescribed for them by the law and regulations.


