g) MEMORANDA.

1. In view of the fact that there are now a large number of Senior Officers in England, who are surplus to requirements, and who cannot be employed in their present rank in England, and as there are few demands from the Canadian Army Corps in France for officers of a higher rank than that of Lieutenant, after due consideration it has been decided that up to and including the 15th June, 1917, all officers of the Canadian Expeditionary Force who arrived in England previous to the 15th May, 1917, and who hold a higher rank than that of Lieutenant in the C.E.F., and who are surplus to requirements, will have the option of reverting, subject to the consent of the O. C. Area, to the rank of Lieutenant, for the purpose of becoming available as reinforcements Overseas, or of returning to Canada, if they so prefer, instead of reverting. All such reversions to take effect from the 15th June, 1917, or such prior date on which they may revert.

In respect of all officers who have arrived, or may arrive in England from Canada, subsequent to the 15th May, these officers shall have the option of reverting to the rank of Lieutenant within one month of their arrival in England; and if they do not desire to so revert they will be returned to Canada. All such reversions to take effect from date one month after arrival in England.

- 2. Officers who have been returned from France either as Casualties or on recall for specific purposes, and subsequently have received a higher rank in Canada, will not be compelled to revert to a rank lower than that which they held on leaving France.
- 3. Officers who do not desire to revert to the rank of Lieutenant will be returned to Canada, and arrangements will be made for their return as early as possible.
- 4. All officers will come under the category of surplus officers who are in excess of and not provided for in the authorized establishment of any Unit, and who are not otherwise specially employed, or available for drafts.
- 5. Officers Commanding Areas should report if they recommend an Officer who desires to revert as suitable or otherwise to serve as a Lieutenant. If not suitable, the officer will be returned to Canada.
